THE EXPAT FIELD TEAM WAS ALSO HIRED AND BEGAN TO PROVIDE KEY MENTORSHIP, TRAINING AND SUPPORT TO LOCAL TEAM. NURU'S LAUNCHED ITS PROGRAM PLANNING PROCESS, ITS CO-DESIGN PROCESS, IN 2018. THE DESIGN PROCESS WILL CULMINATE IN A PROGRAM PROPOSAL AND LAUNCH IN EARLY 2019.
